CENTRAL UTAH ART CENTER UPDATE

As many of you are aware, Ephraim City has been sued by the Central Utah Art Center (CUAC). Roughly two years ago, the CUAC approached the city for their annual funding request and the City set forth certain requirements that financing would be conditioned on. Some of those requirements were to seek additional sources of revenue from around the county, allow more than just Contemporary art, opening the door to many local artists, do more community engagement events, and provide a service to Ephraim City residents. A year after these require-

ments were set, the CUAC again approached the council for funding and admitted to not fulfilling their commitments from the previous year and asked to have one more year to do so.

Through much deliberation and several public meetings the City decided to terminate funding to the CUAC and evict them from the City owned building they were occupying due to their failure to perform. In time, the CUAC refused to leave the building, threatened law suits, and rejected an offer to settle from the

City. As a result, the City had to file an eviction action in the district court in Manti to have a judge remove them from the building. The CUAC countersued claiming that the City violated its



constitutional right to show art. The City responded to their claim, denying the allegations of censorship. The CUAC then filed the same claim in the Federal District Court on constitu-

tional grounds. Ephraim City has filed a motion for summary judgment in the State action and is awaiting further proceedings in the federal case.

EPHRAIM CITY BUSINESS LICENSING

The City is often asked the question, ***"WHY ARE MUNICIPAL BUSINESS LICENSES REQUIRED?"***

Although there are several answers to this question, the main reasons are: local licensure ensures businesses are safe to the public; and, to give protections under the law to which a "licensed" business is entitled.

A business may be visited or inspected and required to fulfill local zoning, building and parking re-

quirements before receiving a license. This ensures employee and public health, safety and welfare. In addition, businesses receiving a local business license and registering their business with the State enables careful business people to verify information about companies with whom they do business.

Another frequently asked question in regards to business licenses is, ***"WHO SHOULD RECEIVE A BUSINESS LICENSE?"***

Ephraim City ordinance states that all "activities engaged within the

City carried on for the purpose of gain or economic profit" require a business license. This includes Home Occupations such as:

- * **Rental Homes and Accessory Apartments**
- * **Internet Sales**
- * **Daycare/Preschools**
- * **Dog Kennels**
- * **Catering/Food Production**
- * **Etc.**
